Redistricting shakes up some communities

A panel of Minnesota judges rolled out new district maps last week that will shape Minnesota elections for the next decade.

Many Minnesotans will have new representation thanks to revised maps released last Tuesday showing the redrawn legislative and congressional districts that will direct the state's elections for the next 10 years. The new maps could

give edges to Democrats or Republicans in their battles for control of Congress or the state Legislature. They'll give hundreds of thousands of Minnesotans new representatives — and give some representatives thousands of new voters. The new districts will reshape what parts of the state are politically competitive, and which communities have the voting weight to elect their own members into office.

The state is constitutionally required to redraw the boundaries of its voting districts to reflect population growth and shifts over

A bid opening for their 2022 seal coat projects was held during Clear Lake Twp.'s. February meeting. Bids were received from Astech, St. Joseph Pearson, and Allied Blacktop.

Twp. Engineer Terrance Vander EVK opened and summarized each bid for the board, with Allied Blacktop coming in significantly lower than the other two contractors. He indicated he will thoroughly review each bid in the coming week.

A motion carried awarding the projects to Allied for \$67,750.

Mailbox Ordinance

Edits were recommended by the township's attorney after review of the new mailbox ordinance, and it was recommended it be included as part of their building permits along with language regarding new construction or reconstruction. Eyk added that it was critical to include the height of the mailbox and the distance it needs to be located off of the bituminous.

Big Lake Middle School held its History Day last week. Sixth, seventh, and eighth-graders showed off their knowledge on the theme of "debate and diplomacy."


The Projects

Bill to pay off UI debt passes Senate

"A \$2.73 billion proposal, SF 2677, to immediately pay off the state's \$1.2 billion in Unemployment Insurance (UI) debt today passed out of the Senate," said Senator Mary Kiffmeyer. This bill would pay the accruing interest, replenish the trust fund, protect employees' benefits and help businesses sur-

On Jan. 1, 2020, Minnesota's UI trust fund balance was \$1.7 billion. However, the many people claiming unemployment during the pandemic greatly drew down the UI trust fund to the point where it hit zero. As a temporary solution, the state borrowed money from the federal government resulting in a negative balance of \$1.2 billion in debt.

The state is currently paying over \$50,000 a day on interest charges to the federal government for the

"Last year, we tried to get Governor Walz to repay the federal government earlier using the federal emergency assistance fund to avoid daily interest. It is very frustrating that the governor knew this back then and our state has continued to incur more debt since," Kiffmeyer said. "Now, the governor is looking to do this at the end of session in May thus

accruing even more inter-

est. We need this done before March 15 when three premium surcharges would take effect.'

Employees do not pay into the unemployment insurance fund. This is paid by the employer and is a special charge that goes on every paycheck. Until the fund reaches a level considered adequate, state businesses would be penalized through a total of 16.5% average higher premium surcharges.


"If employers are required to pay higher premiums, they will not have the money to hire employees and increase salaries or buy new equipment. And it puts at risk future employee benefits," Kiffmeyer said. "Small businesses, which make up 75% of all businesses, are already struggling due to the pandemic. Those who survived could now be forced to close due to these greatly increased premiums. Paying off Minnesota's UI debt is just good government. Our businesses and employees need the Legislature and governor to get this done

According to the Minnesota Department of Employment and Economic Development, it would take more than 10 years of additional higher taxes on businesses to replenish the UI trust funds to blink off additional taxes and end the federal government tax penalty.

SF 2677 will now go to the House of Representatives for further consideration.

Founded in 1994 by access to over \$750,000 County taxpayers Business Expo/Craft Fair

Sherburne County residents and businesses did their part to support local government programs and services in 2021, paying the highest percentage of property taxes in the last seven

A report by the Sherburne County Auditor/Treasurer this week shows the county collected 99.50% of property taxes levied in 2021, or \$51,971,914.69 of \$52,235,670.64.

That percentage topped the 2020 figure of 99.35%, when the county collected \$50,174,477.48 of \$50,503,073.33.

Figures for prior years were: 2019 (99.31%), 2018 (99.41%), 2017 (99.27%), 2016 (99.09%) and 2015 (98.99%).

Taxpayers also dug in to cover previous years' unpaid bills. In 2021, the county collected \$248,647.17 of 2020 taxes and \$52,006.01 from 2019.

Service Agreement

The Board of Commissioners approved a master service agreement between Sherburne County and Braun Intertec for geotechnical, construction material testing, and phase I environmental site assessment services for the years 2022 and 2023.

The public works department solicited a Request for Proposals (RFP) from three consulting firms: American Engineering Testing, Braun Intertec and Independent Testing Technologies. After reviewing the proposals, it was determined that Braun Intertec met the requirements of the RFP and has a reputable history of working with Sherburne County.

The two-year contract is expected to save the county staff time by not having to solicit proposals every time there is a need for geotechnical, construction material testing, and phase I environmental site assessment

For starters, bills have been authored eliminating the state tax on Social Security and protecting businesses from suffering the injustice of a six-year unemployment insurance tax increase at a time the state has a \$7.7 billion

More than 35 other states already have used federal COVID relief funds to address their UI deficit, but Minnesota remains one of the states that literally has not taken care of business. We only have until March 15 to prevent this tax increase from kicking in, so it is good to see the Senate is advancing legislation with bipartisan support to solve this problem. It's been a rougher road over in the House, where the majority's initial plan only addresses part of the issue and still results in a six-year tax increase, per the Minnesota Department of Employment and Economic Development.

Our small businesses have been through enough over the last couple of years and it's time to do right by them. With inflation soaring to 40-year highs, supply chain issues, workforce challenges, and more stacked against them, we should not be subjecting our businesses to higher taxes at a time when Minnesota has a record-set-



PATRIOT Bulldog wrestlers roll over Hornets for State Tournament berth

Last Friday, the Becker Bulldog wrestling team rolled to a 45-21 victory over the Big Lake Hornets in the Section 6AA finals to give Becker its second state wrestling tournament berth in school history. The only other appearance for Becker was in 2003, when veteran coach Brad Novak led his charges to St. Paul.

This season, first year coach Travis Holt took over the head coaching duties for a team that had high expectations with depth and experience across the weight classes, and the wrestlers didn't disappoint in landing a spot in the State Class AA tournament to be held March 3 at the Xcel Energy

"Friday night was a great evening for Becker wrestling," Holt said after his team punched its ticket to state. "This team has had its focus on that event all season long. It was wonderful to watch how hard work and believing in the process has paid off."

Tuesday, the MSHSL conducted a seeding meeting to place the top five teams in their respective spots in the bracket, followed by a random draw for the last three spots. Becker landed the #3 seed, meaning it will open state competition as a team on March 3 at 9 a.m. at the Xcel Energy Center with a contest against unseeded Thief River Falls.

If the Bulldogs win, their semifinal match will be at 1 p.m. against the winner of the #2 seed Kas-

son-Mantorville versus unseeded Mora match, while a loss in the opening round would put the Bulldogs in the consolation bracket (11 a.m. match).

The third place contest is scheduled for 5 p.m., while the finals are slated for 7 p.m. in the one day tournament.

This week, the Bulldogs wrestled in the individual portion of the section tournament Friday and Saturday in Monticello, as a number of Bulldogs were looking to secure their spot in the state individual wrestling tournament. Complete details will be covered in next week's Patriot.

'Although we continue to chase individual section championships, that team title means a lot for this program and will continue to set high expectations and goals for future teams," Holt said.

Hornets

In last Friday's clash on the mat, there were few surprises as both teams know each other well, especially coming off the January 31

match in Becker where the Bulldogs won 8 of 14 individual matches and claimed the M8 Title with a 37-26

This time, the results were even better for Becker, as they won nine weight classes en route to the convincing win.

Becker trailed 0-6 heading into the 120 pound match when Landen Kujawa scored a 20-5 technical fall to close the gap to The Hornets then won

two in a row to claim an 18-5 lead, but Becker's Ethan Anderson wrestled at 138 against Zack Smith and was able to pull off a first period fall for a big six points for the Bulldogs. At 145, Owen Angell

picked up a huge major decision for the Bulldogs at a weight class they had lost to the Hornets in the M8 championship match.

Woodpeckers have extremely stiff tail feathers.







Snowmobiling

machine is good to go. Most of the time, Ewing will be driving over 100 mph, from March 8 at noon to March 9 at noon

The tail plays a crucial role in clinging to the side of a tree. The feet are only two legs of the tripod that the woodpecker needs to cling to a vertical surface. The tail is the third leg and is absolutely essential. They

push so hard on the tail that the feathers often bend under the pressure.

The fact that woodpeckers excavate holes in trees is totally amazing. What is even more amazing is that they excavate these cavities with their face. Seriously, they use their beak, which would be comparable

to our teeth, to chisel holes in trees. If you don't think this is amazing, I challenge you to pick up a piece of firewood and excavate a hole in it with any part of your own body.

Sure, excavating holes in trees is amazing but taking it one step further, they do this without suffering any brain injury (concussion). Studies shows that on average a woodpecker pecks or drums on the hard surface of a tree about 12,000 strikes per day. That's a lot of impacts for the brain to endure every day. So how do they accomplish this without damaging their brain? As are most things in nature, it's a combination of factors.

First, the brain of the woodpecker has a smooth surface which allows for more contact with the inside of the skull. This might seem counter intuitive but having a brain that sloshes

around the skull isn't good for high impacts. Woodpeckers have extraordinarily little space between the skull and brain, called the subdural space, and therefore don't have much cerebrospinal fluid, unlike our own skull and

brain. Again, this helps to stabilize the brain within the skull.

The bill of the bird is located in a position that allows the maximum force from the impact to be concentrated just below the brain. Woodpeckers also have tongues so long that the tongue leaves the mouth of the bird and wraps around the outside of the skull helping to also cushion the brain.

The size of a woodpecker's brain is relatively small, and therefore doesn't have a lot of mass. Since the brain is lightweight, it doesn't build up enough force to cause damage to the nupon impact. Woodpeckers also have a

brain upon impact. Woodpeckers also have a small cushion-like material between the bill and skull which helps to absorb each impact. All these things add up to a woodpecker who doesn't get a concussion when it bangs its face against a tree.

This is just the beginning of how different woodpeckers are from other birds. Anyway, this is why I find myself sitting in sub zero temperatures just to capture a few images of the amazing woodpeckers. Until next time...

Question: I am a new parent and I am not sure if I am doing this child car seat thing properly. Is there somewhere I can go to find out if I am doing it right? Thank you.

Answer: Congratulations on parenthood! I know the feeling and there will only be more questions as time goes on. For child passenger safety, the Minnesota Department of Public Safety Office of Traffic Safety has a map that you can click on for your area, and it will bring you to a "car seat check." https://dps.mn.gov/divisions/ots/child-passenger-safety/

If this doesn't work out, a person can always check with their local police department/sheriff's office, local public health department or any hospital and clinic. If they are unable to help, they should be able to point you in the right direction.

Minnesota Child Car Seat Law and Steps
•In Minnesota, all children must be in a child restraint until they are 4'9" tall, or at least age 8, whichever comes first.

•Rear-facing child seats - Keep your child rear-facing as long as possible. Your child should remain in a rear-facing car seat until he or she reaches the top height or weight limit allowed by your car seat's manufacturer. •Forward-facing seats - Once your child outgrows the rear-facing

car seat, your child is ready to travel in a forward-facing car seat with a harness and tether. Keep your child in a forward-facing car seat with a harness and tether until he or she reaches the top height or weight limit allowed by your car seat's manufacturer.

*Booster seats - Use after outgrowing a forward-facing harnessed restraint; safest to remain in a booster until 4 feet 9 inches tall, or at least age 8, whichever comes first.

•Seat belts - Use when children can sit with their back against the vehicle seat and have their knees bent comfortably over the edge with their feet touching the floor.

Keeping Children Safe
•From 2016-2020, 20 children (ages 0–7) were killed in motor vehicles and only 40 percent of the victims were known to be properly secured.
•Of the 86 children (ages 0–7) seriously injured in motor vehicles in the past five years, only 50 percent of the victims were

known to be properly secured.

•Of the 15,672 children ages 0–7 who were properly restrained in the past five years, 88 percent were not injured, and another 9 percent sustained only minor or possible injuries.

The proceeds of the taxes authorized by the Act shall be used to pay for the costs of improvements to the Sportsman Park/Ballfields, Riverside Park, Lions Park/Pavilion, Cedar South Park also known as Eldorado Park, and Spring Street Park; improvements to and extension of the River County Bike Trail; acquisition, and construction, improvement, and development of regional parks, bicycle trails, park land, open space, and of a pedestrian walkways, as described in the city improvement plan adopted by the city council by resolution on December 12, 2006, and walkway over Interstate 94 and State Highway 24; and the acquisition of land and construction of buildings for a community and recreation center. The total amount of revenues from the taxes used to fund these projects is \$12,000,000 plus any associated bond costs.

CITY OF CLEARWATER ORDINANCE 2022-03 AN ORDINANCE AMENDING CHAPTERS 22 AND 26 OF THE CITY CODE

REGARDING POSSESSION AND DISCHARGE OF WEAPONS ON CITY PROPERTY The City Council of the City of Clearwater ordains as follows:

Section 1. Chapter 22 of the City Code is amended by adding a new Article III titled "Discharge of Weapons on City Property" as follows: ARTICLE III. - WEAPONS DISCHARGE ON CITY PROPERTY

The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning: Public property means any city park, right-of-way, or any other real property owned by the City of

Right-of-way means land acquired by reservation or dedication intended for public use, and intended to be occupied or which is occupied by a street, trial, railroad, utility lines, oil or gas pipeline, water line,

sanitary sewer, storm sewer or other similar uses. Weapon means any device from which shot or a projectile of any type can be discharged by means of an explosive, gas or compressed air or otherwise propelled, including, but not limited to, firearms, bb guns, bows and arrows, slings, spring guns, pistols, semiautomatic military-style assault weapon, or any other device capable of injuring or killing a human being.

Sec. 22-33. - General discharge prohibition.

Except as provided in Section 22-34, no person shall fire or discharge, or cause to be fired or discharged, any weapon on any public property within the corporate limits of the city. Sec. 22-34. - Exceptions.

Excepted from the provisions of Section 22-33 shall be the following:

- (1) Discharge of any firearms by duly authorized peace officers or military authorities. (2) Discharge of a firearm when done in lawful defense of their person or property or family.
- (3) Discharge of a bow and arrow on a recognized archery range or discharge of a bow and arrow under a program supervised by school or public officials.

(4) Discharge of a firearm at a publicly owned or managed shooting range.

(5) Discharge of a firearm pursuant to state or federal law authorizing such discharge.

Section 2. Section 26-19 of the City Code is amended by adding the double-underlined language and deleting the stricken language to the definition of "weapon" as follows:

Weapon means any device from which shot or a projectile of any type can be discharged by means of an explosive, gas or compressed air or otherwise propelled, including, but not limited to, firearms, bb guns, bows and arrows, slings, and spring guns, pistols, semiautomatic military-style assault weapon, or any other device capable of injuring or killing a human being.

Section 3. Section 26-26(6) of the City Code is amended by adding the double-underlined language and deleting the stricken language to the definition of "weapon" as follows:

Sec. 26-22. - Protection of natural resources and wildlife.

It shall be unlawful for any person to:

(1) Kill, trap, hunt, pursue or in any manner disturb or cause to be disturbed any species of wildlife within a park, except that fishing by angling only may be permitted in designated areas.

(2) Shoot any weapon into a park from beyond park boundaries.

- (3) Bring a dog, cat, or other pet into a park unless caged or kept on a leash not more than six feet in length, or tether any animal to a tree or other plant.
- (4) Except as otherwise authorized by law, permit a dog, cat or other pet to enter a nature center area, refuge area, picnic area, park building, or other unauthorized area within a park or any park where their
- (5) Permit a dog, cat, or other pet to disturb, harass, or interfere with any park visitor or a park visitor's (6) Possess any weapon within a park, except for a as follows:

(a) A bow and arrow to be used for bowfishing, if the arrows must be are attached to the bow with

a tethered line and broadheads must have barbs for bowfishing, as regulated by the DNR and otherwise comply with all applicable bowfishing regulations. (b) Possession of any weapons by duly authorized peace officers or military authorities.

(c) Possession of a firearm at a publicly owned or managed shooting range.

- (d) Possession of a firearm pursuant to a valid permit to carry under Minnesota Statutes, Section
- (e) Possession of a firearm pursuant to state or federal law authorizing such possession. (7) Release within a park any plant, chemical or other agent potentially harmful to the vegetation or

(8) Remove any animal, living or dead, from a park, and any animal so removed or taken contrary to the provisions of this article or laws of the state shall be considered contraband and subject to seizure

(9) Injure, destroy, or remove any tree, flower, shrub, plant, rock, soil or mineral in a park. Section 4. This Ordinance shall be effective immediately upon its passage and publication. ADOPTED THIS 14th DAY OF FEBRUARY 2022

St. Cloud Airport launches new paid parking system

On March 1, 2022 the St. Cloud Regional Airport launches its new paid parking system for on-premise parking in both the paved and gravel overflow parking lots. The cost for long-term on-premises parking is five dollars per 24-hour

The change is intended to shift some of the St. Cloud Regional Airport operating expenses from City of St. Cloud property taxes to user fees for those who make use of the Airport facilities.

"We also expect this user fee to help manage capacity in the parking lots during peak travel periods," said Airport Authority Board Chair Brian Myres.
"This will ensure space

is available for those who need it," continued Myres.

Short term parking will continue to be free at the St. Cloud Regional Airport for up to two hours for meeters and greeters.

"Short term users can

park in any of the available spots in both the paved and gravel overflow parking lots," said Airport Executive Director Bill Towle. "We still want people

to be able to assist those they are bringing to the Airport for a flight, as well as be able to come inside and greet people arriving at the Airport," said Towle.

The paid parking sys-

the pand panking system is a Pay by Plate parking kiosk, meaning the license plate is the proof of payment. There will be two convenient kiosks: one located outside the terminal building and the other inside the terminal. Pay kiosks, or stations, will be credit card only. Don't forget to remember the license plate number when leaving the vehicle!

The kiosks are easy to use touch screens that

prompt users through the process. Enter the license plate number. Select payment method. Choose length of stay. Users can enter their cell phone numbers to receive an electronic receipt or print a receipt for

records. No need to place a

receipt on the vehicle dash-

The Airport will also be utilizing the Parkmobile parking app, which will allow customers to use their mobile device to pay instead of needing to use a pay kiosk, making the experience even smoother.

Parkmobile is also being used by the City of St. Cloud for parking in ramps and downtown streets, so many customers may already have the app on their mobile device. Parkmobile is easy to use and has great information on their website at *Parkmobile.io*.



Wright Co. Sheriff's office bids farewell to 35-year employee



Sheriff Sean Deringer said Habisch-Peterson has been an integral part of the Sheriff's Office since 1988 and a valued asset to the office as well as the county's residents

"Annette has certainly shared my vision," Deringer said. "I've always said it comes down to how we treat people. I have very much appreciated Annette's role in the Command Staff and certainly our conversations as we have worked our way forward. I'm going to truly miss her."

She began her law enforcement career as a Sher-

iff's Office Explorer in 1984 when she came to the Wright County Sheriff's Office, she was one of just two women working in the department. She has worn many hats, having worked as a matron, worked in the county jail, worked in dispatch, been a member of the Wright County Honor Guard and a member of the Minnesota Law Enforcement Memorial Association.

Habisch-Peterson thanked her family – parents, husband and three children – for their unwavering support and encouragement throughout her professional life and understanding that at times work had to take precedence over family events. She thanked members of her extended family for giving their unconditional support to her and law enforcement.

Habisch-Peterson has appreciated the versatility she has experienced during her law enforcement career, because she has seen some horrific crime scenes over the years that made her question

how long she could withstand the mental and emotional strain that is inherent with the job as the first to respond to crime scenes nobody wants to see or remember. At times when her emotional bucket seemed to be at its limit, a new empty employment bucket was there to take its place.

"As soon as my buckets got full, there was always an opportunity to change," Habisch-Peterson said. "It was really a blessed career. To the rest of my work family – I've always said I have a blood family and a badge family. My badge family is a bond I will miss the most.

"The last six years serving as a captain in our criminal division has been amazing," Habisch-Peterson added. "To see the dedication, perseverance and compassion these detectives, narcotics agents, SROs, forensics folks, crime scene deputies, evidence techs and our victim advocate in action every day is inspiring. That's what makes coming

to work every day worth it. It can never say that I just hated coming to work because I didn't. I knew that I would have this support system in place at work and we all went through it together. I'm going to miss the routine of coming to work every day. I'm going to miss my badge family the most. I will continue to pray that everybody working at the Sheriff's Office is going to go

The county board thanked Habisch-Peterson for her service to the county, including two commissioners that worked with her at one point in their careers — Christine Husom and Mike Kaczmarek. On behalf of all of Wright County, we owe a debt of gratitude to Captain Habisch-Peterson for her dedication, excellence, work ethic and commitment to the residents of Wright County.

lines for producers to respond to loan servicing actions, including loan deferral consideration for financially distressed and delinquent borrowers. In addition, for the Guaranteed Loan program, flexibilities have been made available to lenders to assist in servicing their customers.
