If we are going to get inflation under control, addressing the price of energy must be our top priority. Last week, the House of Representatives passed legislation that will work to lower energy costs for working Americans.

The Lower Energy Costs Act focuses on two main principles: increasing the production of American energy and reducing regulatory red tape that make it more challenging to expand American energy and natural resource development. This bipartisan, commonsense bill unleashes American energy and drives down costs for American families.

During 2022, the price of natural gas rose to the highest levels in nearly 15 years. According to the U.S. Energy Information Administration, more than 65% of Minnesota households use natural gas to power their homes. As Minnesotans, we understand that home heating isn't just a luxury, it is a life-and-death necessity for many months of the year.

The Lower Energy Costs Act will have major implications for miners in Northern Minnesota as

## **Extreme policy stopped**

We have reached the halfway point of the 2023 legislative session. As we look back at the first part of this year, I want to draw attention to times when Republicans stopped extreme policy in its tracks, despite being in the minority.

## Governor wants \$17K/ month from taxpayers

À recent piece I wrote cited some "Fleecing of Minnesota" examples, highlighting government waste and abuse of taxpayer dollars. Here's another doozy to add to the pile:

We recently learned Gov. Walz and family will be relocating to a \$17,000-a-month lakeside mansion later this year during renovations at the St. Paul governor's residence. It's fair to expect the governor would receive nice accommodations during the time he's displaced from his official residence, but more than \$17,000 PER MONTH? At a total taxpaver cost of \$329,581 in rent? For a year and a half? This is outrageous.

Minnesotans are struggling with soaring interest rates, high inflation, and price increases across the board in this Biden-Walz economy. So what is a tone-deaf governor do at this point? He goes ahead and forces taxpayers fork over \$17,000 a month in rent payments for a palatial lakeside mansion for his family and him.

The governor can lay it on thick and patronize Minnesotans all he wants as the ol' ball coach in a buffalo plaid costume, but actions like this illustrate just how out of touch he is with the everyday Minnesotans - or how little he cares about taxpayers.

There are many more affordable options the governor could have chosen for his temporary residence that would have been far more reasonable for the paying public. A quick online search shows comparable properties are available within the same proximity at a much more reasonable cost. Instead, it's more for thee, not for we.

As if this doesn't look bad enough on its own, it's happening at a time the governor and fellow Democrats propose increasing state spending by 40%, raising taxes despite a massive state surplus, refuse to fully eliminate the state tax on Social Security and propose dramatically underfunding nursing homes. Oh, and they want to le-

tobacco and have plenty of time to advance gender-related issues.

Back to the tax increases: The House Democrat transportation bill alone raises taxes and fees by at least \$4 billion - \$1.71 billion in 2024-25, and by more than \$2.2 billion in 2026-27. This includes: License tab fee increases; \$10 surcharge on license tabs; Motor vehicle sales tax increase; 3/4-cent metro area sales tax increase (for transit); 75-cent delivery tax (everything from Amazon packages to pizza delivery).

Meanwhile, House Republicans are calling attention to the lack of funding for nursing homes in the House majority's budget proposal for the next twoyear cycle, despite the ongoing industry crisis.

As I've asked regarding eliminating the Social Security tax, if we can't support nursing homes at a time the state has a \$17.5 billion surplus, when can we?

Together, with Republican legislators, nursing home providers are calling on the Legislature to take action and ensure our nursing homes have the investments they need to keep caring for our seniors. We made a motion in the House chamber to declare urgency and vote to approve nursing home funding on Thursday, but the majority blocked that effort.

We'll see where things stand after the state's new budget is established. In the meantime, I will continue pushing for our priorities each day in St. Paul, whether it's defending taxpayers, supporting our seniors, advocating for improved public safety, standing up for our constitutional rights, promoting affordable and reliable energy, and more.

For 247 years, the United States has been a beacon of freedom and individual liberty in a world of darkness and tyranny. That light went out on Tuesday, April 4. ## Proposed gambling ordinance draws crowd at Clear Lake City

The Clear Lake City Council met Monday evening and started off with three public hearings, before the agenda turned to

The first two hearings, about a variance request and a change to the vegetation height allowance in the city, drew no speakers.

Then, council held a hearing that proposed the adoption of language to regulate charitable gambling donations for funds generated within the City.

Several members of the Clear Lake Lions spoke about the proposed ordinance, voicing concerns about the intent of the language and how it could restrict their ability to donate to certain causes.

Lion Joe Gruenes quizzed the council members about the purpose of the new ordinance, as well as the wording that pointed to the City being in control

of the donations. He surmised that this could cause the City to have to file the appropriate paperwork with the state's Gambling Control Board

as they dispersed the funds.

"I'm requesting proper clarification of the ordinance," Gruenes stated.

Mayor Tim Goenner responded that the city was hoping to also include Clear Lake Township as an area that could receive the charitable funds and the intent was not to have the council being the ones to disperse the funds.

It was also suggested that the ordinance was modeled closely after what the City of Becker currently has on the books.

There was additional discussion about the allowable donation area being tied to what is referred to as the "trade area" of the city and not necessarily defined by the municipality's borders

suggested to Goenner that the council table the issue

for the evening, allowing the Lions Club members time to review the proposed ordinance, as the language had not been available prior to Monday's meeting.

"It's tough to comment on it if we haven't seen it (the language)," Schmiesing said.

Mayor Goenner then asked for a motion to table the public hearing, and it received unanimous ratification. This will allow the council to reconsider the concept next month with a continuation of the public hearing.

#### **Council Action**

When the regular meeting was called to order, SCSO Sgt. Andy Ochs addressed last month's call load, noting 66 calls for service - about half of which were for traffic stops and security checks.

Next, council adopted a motion to change the lawn vegetation ordinance, providing for eight inches of maximum growth as compared to the previous 12 inch allowance.

Council then discussed a security contract for the city's computers and server,

deferring action until the insurable limits could be explored at a later date.

After considerable discussion, member Chad Nelson then motioned to adopt the city's Business Subsidy Policy, which will allow Clear Lake to consider helping businesses with programs such as Tax Increment Financing or Tax Abatements.

#### In Other Business, the Council:

 Discussed the parking lot at the post office, noting that the owner of the building is responsible for ice removal;

· Heard from City Engineer Keith Yapp and Public Works Director Dustin Luhning that the city's generator is compatible to be used on the lift stations should the need arise;

 Approved the annual hiring of the seasonal public works employee;

 Heard from Goenner about his meeting with St. Cloud Superintendent of Schools Laurie Putnam.

#### Becker 2022 Drinking Water Report Making Safe Drinking Water

Your drinking water comes from a groundwater source: four wells ranging from 53 to 61 feet deep, that draw water from the Quaternary Buried Artesian and Quaternary Water Table aquifers.

Becker works hard to provide you with safe and reliable drinking water that meets federal and state water quality requirements. The purpose of this report is to provide you with information on your drinking water and how to protect our precious water resources.

The U.S. Environmental Protection Agency sets safe drinking water standards. These standards limit the amounts of specific contaminants allowed in drinking water. This ensures that tap water is safe to drink for most people. The U.S. Food and Drug Administration regulates the amount of certain contaminants in bottled water. Bottled water must provide the same public health protection as public tap water.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. #### **Becker Monitoring Results**

This report contains our monitoring results from January 1 to December 31, 2022.

We work with the Minnesota Department of Health to test drinking water for more than 100 contaminants. It is not unusual to detect contaminants in small amounts. No water supply is ever completely free of contaminants. Drinking water standards protect Minnesotans from substances that may be harmful to their health.

### How to Read the Water Quality Data Tables

The tables below show the contaminants we found last year or the most recent time we sampled for that contaminant. They also show the levels of those contaminants and the Environmental Protection Agency's limits. Substances that we tested for but did not find are not included in the tables.

We sample for some contaminants less than once a year because their levels in water are not expected to change from year to year. If we found any of these contaminants the last time we sampled for them, we included them in the tables below with the detection date.

We may have done additional monitoring for contaminants that are not included in the Safe Drinking Water Act. To request a copy of these results, call the Minnesota Department of Health at 651-201-4700 or 1-800-818-9318 between 8:00 a.m. and 4:30 p.m., Monday through Friday.

Some contaminants are monitored regularly throughout the year, and rolling (or moving) annual averages are used to manage compliance. Because of this averaging, there are times where the Range of Detected Test Results for the calendar year is lower than the Highest Average or Highest Single Test Result, because it occurred in the previous calendar year.

#### Definitions

- AL (Action Level): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- EPA: Environmental Protection Agency
- MCL (Maximum contaminant level): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- MCLG (Maximum contaminant level goal): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety
- MRDL (Maximum residual disinfectant level): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- MRDLG (Maximum residual disinfectant level goal): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- N/A (Not applicable): Does not apply.
- ppb (parts per billion): One part per billion in water is like one drop in one billion drops of water, or about one drop in a swimming pool. ppb is the same as micrograms per liter ( $\mu g/l$ ).
- ppm (parts per million): One part per million is like one drop in one million drops of water, or about one cup in a swimming pool. ppm is the same as milligrams per liter (mg/l).

### Monitoring Results - Unregulated Substances

In addition to testing drinking water for contaminants regulated under the Safe Drinking Water Act, we sometimes also monitor for contaminants that are not regulated. Unregulated contaminants do not have legal limits for drinking water.

Detection alone of a regulated or unregulated contaminant should not cause concern. The meaning of a detection should be determined considering current health effects information. We are often still learning about the health effects, so this information can change over time.

The following table shows the unregulated contaminants we detected last year, as well as human-health based guidance values for comparison, where available. The comparison values are based only on potential health impacts and do not consider our ability to measure contaminants at very low concentrations or the cost and technology of prevention and/or treatment. They may be set at levels that are costly, challenging, or impossible for water systems to meet (for example, large-scale treatment technology may not exist for a given contaminant).

A person drinking water with a contaminant at or below the comparison value would be at little or no risk for harmful health effects. If the level of a contaminant is above the comparison value, people of a certain age or with special health conditions - like a fetus, infants, children, elderly, and people with impaired immunity - may need to take extra precautions. Because these contaminants are unregulated, EPA and MDH require no particular action based on detection of an unregulated contaminant. We are notifying you of the unregulated contaminants we have detected as a public education opportunity

### **Drinking Water Sources**

Minnesota's primary drinking water sources are groundwater and surface water. Groundwater is the water found in aquifers beneath the surface of the land. Groundwater supplies 75 percent of Minnesota's drinking water. Surface water is the water in lakes, rivers, and streams above the surface of the land. Surface water supplies 25 percent of Minnesota's drinking water.

Contaminants can get in drinking water sources from the natural environment and from people's daily activities. There are five main types of contaminants in drinking water sources.

- Microbial contaminants, such as viruses, bacteria, and parasites. Sources include sewage treatment plants, septic systems, agricultural livestock operations, pets, and wildlife.
- Inorganic contaminants include salts and metals from natural sources (e.g. rock and soil), oil and gas production, mining and farming operations, urban stormwater runoff, and wastewater discharges
- Pesticides and herbicides are chemicals used to reduce or kill unwanted plants and pests. Sources include agriculture, urban stormwater runoff, and commercial and residential properties.
- Organic chemical contaminants include synthetic and volatile organic compounds. Sources include industrial processes and petroleum production, gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants such as radium, thorium, and uranium isotopes come from natural sources (e.g. radon gas from soils and rock), mining operations, and oil and gas production.

The Minnesota Department of Health provides information about your drinking water source(s) in a source water assessment, including:

- How Becker is protecting your drinking water source(s);
- Nearby threats to your drinking water sources;
- How easily water and pollution can move from the surface of the land into drinking water sources, based on natural geology and the way wells are constructed.

#### Lead in Drinking Water

You may be in contact with lead through paint, water, dust, soil, food, hobbies, or your job. Coming in contact with lead can cause serious health problems for everyone. There is no safe level of lead. Babies, children under six years, and pregnant women are at the highest risk.

Lead is rarely in a drinking water source, but it can get in your drinking water as it passes through lead service lines and your household plumbing system. Becker is responsible for providing high quality drinking water, but it cannot control the plumbing materials used in private buildings.

Read below to learn how you can protect yourself from lead in drinking water.

- 1. Let the water run for 30-60 seconds before using it for drinking or cooking if the water has not been turned on in over six hours. If you have a lead service line, you may need to let the water run longer. A service line is the underground pipe that brings water from the main water pipe under the street to your home.
  - You can find out if you have a lead service line by contacting your public water system, or you can check by following the steps at: https://www.mprnews.org/story/2016/06/24/ npr-find-lead-pipes-in-your-home
  - The only way to know if lead has been reduced by letting it run is to check with a test. If letting the water run does not reduce lead, consider other options to reduce your exposure.
- Use cold water for drinking, making food, and making baby for-2. mula. Hot water releases more lead from pipes than cold water.
  - Test your water. In most cases, letting the water run and using cold water for drinking and cooking should keep lead levels low in your drinking water. If you are still concerned about lead, arrange with a laboratory to test your tap water. Testing your water is important if young children or pregnant women drink your tap water.





Open houses scheduled to provide information and answer questions about transmission line expansion

Xcel Energy, along with other utility partners, is proposing new transmission line infrastructure that will improve electric reliability in the region, reduce congestion on the transmission system, and increase access to new low-cost renewable energy in the coming years.

The Alexandria-Big Oaks transmission line proposal would add a second transmission circuit on the open side of the existing CapX2020 transmission line structures between Alexandria and Monticello, Minnesota, along with new structures to connect to the new Big Oaks substation, which will be built near Xcel Energy's Sherco power plant.

## CAPX2020 HISTORY

When originally approved, regulators and utilities believed the transmission grid would eventually need expansion. Rather than build an entirely new transmission line, the MN Public Utilities Commission directed CapX2020 to build the Fargo-St. Cloud/Monticello line capable of adding a 'second circuit,' which would reduce the amount of future infrastructure. The utilities involved in this project include Great River Energy, Minnesota Power, Missouri River Energy Services, Otter Tail Power Company, and Xcel Energy.

### **BIG STONE SOUTH-ALEXANDRIA**

The Big Stone South-Alexandria segment will connect a new 345-kV transmission line between the existing Big Stone South substation in northeast South Dakota and the Alexandria substation near Alexandria, Minnesota. Otter Tail Power Company and Missouri River Energy Services, the companies leading this portion of the project, will work closely with landowners, communities, and local officials to



The Lynden Twp. Board of Supervisors discussed numerous agenda items during their first three

### meetings of the year. Food Shelf

Representatives from the Clearwater/Clear Lake Area Food Shelf approached the board to request funding for a new freezer and refrigerator. They presented a quote of \$5,056 for a three door refrigerator and \$6,754 for a three door freezer, for a total of \$12,410.

It was explained that they're in the process of funding a food shelf building of their own as they need more space. Currently they have had to turn away donated food because there's no room to store it. The new refrigerator and freezer will help with the room problem and in the future they can be moved to the new building.

The land for the new building was purchased from Rejoice Lutheran Church. When asked, the board was informed they plan to start working on their new building in April 2024. The hope is to also install a commercial kitchen in the building sometime in the future to help teach recipients how to prepare the food they're given.

The organization will be attending other area township meetings to ask for donations as well; a kickoff fundraiser is being held at the Clearwater Legion on April 15.

### JK Landscape

A public hearing was held in February regarding JK Landscape/Jerry Konz to vacate a portion of a drainage and utility easement.

Mike Couri recommended the township retain for future purposes.

#### **Other Business**

A request was put forth to the board for a conditional use permit to store commercial vehicles indoors on a Franklin Road property; the applicants were told they needed one by Stearns Co. The board informed them they need to first submit an application; the planning commission will then review it and make a recommendation to the township board.

Anderson Trucking's application for rezoning from A-40 to Industrial was passed through a motion; adjacent properties are already zoned Industrial.

A motion carried making it the policy of the township to require an applicant seeking vacation of any public drainage, utility, or road easement to have such easements marked in accordance with Gopher One State Call (GOSC) at the applicant's expense.



## Emmer holds energy roundtable in Becker

Congressman Tom Emmer (MN-06) hosted a roundtable at the Becker Community Center Tuesday with over a dozen

Minnesota leaders and energy producers to discuss H.R. 1, the Lower Energy Costs Act, which passed the U.S. House of Representatives late last week.

"The core tenets of H.R. 1 are simple: lower costs for Americans, remove the bureaucratic red tape holding our energy industry back, and restore America's energy inde-pendence," said Emmer.

The bill will increase domestic energy production, reform the permitting process for new energy projects, repeal the \$6 billion natural gas tax and the \$27 billion 'green bank' slush fund. The Lower Energy Costs Act will also boost domestic production of critical minerals like those mined in Minnesota's Iron Range.

Those in attendance included Becker Mayor Tracy Bertram, Becker Council Member Rick Hendrickson, Becker Gity Administrator Greg Lerud, Big Lake Mayor Paul Knier and Sen. Andrew Mathews, amongst others. Emmer allowed for each individual to express their concerns, ask questions or offer suggestions on powering the bill forward.

Many of the greatest concerns were attributed to the lengthy permitting problems and regulatory rules that drag down schedules and delay production.

"We believe permitting reform is urgently needed to move forward with the ongoing energy transition while keeping the power grid

operating reliably," said Dar-

rick Moe, President & CEO of the Minnesota Rural Electric Association

Moe had said it typically takes around 10 years to get a transmission line constructed compared to just 3-4 years in other countries. Eight of those 10 years, Moe says, get clogged up in permitting and regulations.

This bill takes tangible steps that will allow the market and innovations to flourish, driving down costs and moving us meaningfully to the clean energy future we are striving for," said Kayla Christensen, Executive Director of Minnesota Conservative Energy Forum.



## Becker archery sends 10 to Nationals
