Sherburne board recognizes employees' pandemic efforts

SHERBURNE

The Sherburne County Board of Commissioners met Tuesday morning and heard several agency updates before approving a proclamation recognizing the efforts of county employees during the COVID-19 pandemic.

Board chair Raeanne Danielowski read aloud the document, which recognized the commitment and public service excellence of the county's workforce over the past 18 months, and proclaimed August 3 as the date to celebrate the workers' accomplishments with a lunch time ice cream social. Danielowski further noted that Sherburne County was one of the few in Minnesota to stay open to the extent possible during last year's health emergency. The resolution was adopted unanimously by the board, with commissioners Felix Schmiesing and Lisa Fobbe being absent from the meeting. **SSTS Loan Fund**

For several years, the county has offered a low interest loan fund for people wishing to bring their septic systems into ordinance compliance. Solid Waste Administrator Dave Lucas presented several amendments to the highly popular program, including an interest rate adjustment and a provision allowing for the funds to be used for water source wells that have to be established or relocated due to the placement of new septic systems.

The fund is set up to help homeowners with the costs of coming into compliance, and the interest rate is set to ensure the county neither makes nor loses

The board heard from Great River Regional Library

(GRRL) Executive Director Karen Pundsack regarding the 2022 library system budget. The li-

brary system receives a majority of its funding from the six coun-

ties that it serves and their 2022 budget was similar to years past, with Sherburne County being asked to add \$33 to its approximately \$1 million contribution.

Pundsack outlined preliminary plans for the expansion of open hours service to the branches in Becker and Big Lake, while also noting the elimination of the daily overdue fine system where the libraries would collect "dimes" for overdue books. The practice has little effect on the budget and in many cases adversely affected library usage, especially among youth with transportation barriers.

Despite the elimination of the daily fines, the system will still seek restitution for any materials that are not eventually returned.



Becker Schools will not require masks this year

Monday, Supt. Jeremy Schmidt reported that he was approached by around a dozen concerned parents during the afternoon before the Becker School Board meeting regarding the issue of masks. He recommended to the board that the schools continue to follow the law and the recommendations of the state to the word: meaning that, if something is required by law, the school will follow that law, and if something is strongly recommended, the school will strongly recommend it.

Currently, there are only two COVID-19 safety guidelines required of schools. Firstly, anyone using public transportation (school buses) needs to wear face coverings, Secondly, all COVID-19 positive cases need to be reported to the state, either by the school or by the family. The school will continue to require increased sanitation around the schools, including washing and sanitizing hands, and disinfecting the schools. "Unless it's covered by law or by some type of executive order," Schmidt said, "I don't have a

lot of interest in policing [it]."

Of course, families and students are welcome to implement any precautions with which they are comfortable, including face masks and vaccinations.

The schools will also be following their long-standing rule regarding vomiting and fever in students: students must be free of fever or vomiting for 24 hours before they may return to school.

The board has not yet heard from the Minnesota State High School League on whether masks will be required for sports, and to what

She cited the board's previously stated commitment to transparency and the necessity of keeping concerned citizens informed and educated about matters concerning the school, including critical race theory and rights of LGBTQ+ stu-

Board member Mark Swanson asked Armstrong if there was a lot of talk about these issues in the community,

Schmidt stated that the Minnesota School Board Association (MSBA) board of assembly will be held in December. The meeting will focus on discussing and approving or disapproving new MSBA policy. Board chair Mark Swanson will again be representing Becker at this meeting.



St. Cloud schools and MSEA reach tentative agreement

St. Cloud Area School District 742 and the Minnesota School Employees Association are pleased to report that they have reached a tentative twoyear agreement for the 2021-2023 contract with the paraeducator employees of the

district, subject to ratification bу unit members and approval bv the School

Board. The paraprofessional bargaining unit represents approximately 300 employees of the school district who perform critical student support services in St. Cloud schools and programs every day.

Superintendent Willie Jett says, "We are thrilled to reach a settlement with this important employee group before the start of the school year. Their hard work, dedication, and commitment help ensure the academic success of our students while creating a caring and supportive environment every day in our schools."

The 2019-2021 contract expired on June 30th and district administration and the paraprofessional

bargaining team worked quickly to develop a mutually acceptable agreement before the start of the school year. For 2021-2022 and 2022-2023, for each year of the contract the terms of the agreement include increases in hourly rates for new employees, additional increases in hourly wages for current staff over and above the new starting rates, and increases to lon-

gevity pay for employees



with five or more years of

In addition to these pay changes, the school board has authorized significant increases in health insurance contributions for all non-licensed school staff, as well as \$1,500 per year in recruitment and retention stipends for all employees of the School District for the next two years.

Paraprofessional staff will vote on the agreement after returning to school in September and if approved, the School Board will vote on the agreement at their regularly scheduled board meeting on September 15th



Stone Road rocks it out at Lake George





Teaching Students about Race Issues –

When I was in school, which was not that long ago, I was taught about how the American Civil War led to the end of slavery in America. I learned about the Jim Crow laws and how they were eventually abandoned. I learned about how those of minority races in America have fought for their equal rights. But, perhaps more importantly than learning about these essential events in US history, I was taught to celebrate this progress, and to celebrate all the races and cultures that combine into this big melting pot of a country. I was taught to cherish the individuality of every American citizen and their unobstructed right to voice that individuality.

But not once was I taught to feel guilty about being a slave owner. Because I've never been a slave owner. I've never been told that I should be ashamed for believing in Jim Crow laws. That's because I don't believe in them. And I don't believe I should feel guilty about the things done many years ago by people I've never met. I don't claim them as family, even if we might be related.

I reviewed the school board meetings of Becker

and Big Lake this week for articles that can be found elsewhere in the paper. At both meetings, concerned parents and individuals in the community stepped forward to ask that the schools be wary of Critical Race Theory (or CRT) becoming part of our students' education. They were concerned about students being told they are victims or oppressors, with no middle ground, based on the color of their skin.

I'm definitely against labelling any child as either of these things. Labelling an innocent person as an oppressor teaches them to feel constantly guilty, inadequate, and bad about themselves, even if they're the kindest students you could want. Telling someone they are a victim is possibly much worse. It teaches them that they don't have the autonomy to be anything but a victim: everything happens TO them.

It's absolutely important to teach students about some of the darker aspects of American history. It happened, and it shaped the world we live in. It's also important not to teach kids to think of themselves either as bad people or as people who have no autonomy. Neither is true. No matter what the race of the student.

Possibly the most important lesson from the Bible is to "Love thy neighbor." But sometimes we forget the second part of that statement: "Love thy neighbor as thyself." That means we should not only love and cherish all people of all races, cultures, sexualities, and political parties (though we don't necessarily LIKE each other all the time!), but also to love and cherish ourselves to the same extent.

I love my community and its members, and I hope to have the honor of continuing to hear people stand up for their beliefs, as is our right as Americans.

Appointed to statewide committee

(Editor's Note: The following article was submitted by the Shane Mekeland team).

I, State Rep. Shane Mekeland, R-Clear Lake, have accepted an appointment to a panel charged with developing a statewide energy transition plan.

The Energy Transition Advisory Committee was established earlier this year to, in part, address issues that may arise amid evolving energy production in Minnesota. I, who am a member of the House Climate and Energy Finance and Policy Committee, said my primary focus as a member of the committee will be to mitigate the impacts of facility retirements and projected job losses in communities.

I continue advocating for an all-of-the-above approach to energy. We need an affordable, reliable, sustainable energy grid. That said, like it or not, certain sources of energy are being

phased out in Minnesota and we need to have a plan in place to handle issues this is causing.

This presents a huge challenge right here in our district as coal plants are being shut down in Becker. My objective with this committee is to identify ways we can recoup the losses we are suffering, while also making sure taxpayer resources are going to the right places. It's the hand we've been dealt, and we need to make the best decisions possible within those constraints.

The committee consists of 18 voting members and eight ex-officio, non-voting members. I am one of four legislators to receive an appointment. Four representatives of impacted communities and three representatives of impacted workers are among the other appointees. The group will advise the governor, related state agency leaders and the legislature on transition issues, established transition programs, economic initiatives, and transition policy.

It is good to have people who work in the trenches, so to speak, involved with this board. It is important to remember policy decisions we make today will impact livelihoods and families tomorrow and having those faces at the table will be valuable as we work.

The committee will meet monthly, starting Sept. 1.

The board called for a special election to fill Kampa's seat. The election will be held November 2.

Supt. Tim Truebenbach encouraged anyone interested in the position to reach out to him for more information about duties associated and how to become a canditdate.

Referendum

The board also called for a special election for a referendum for school grounds maintenance items. The referendum and the election of a new board member will appear on the same ballot in November. There will be no tax increase due to replacing old debt. According to the survey sent out, most of the items needing maintenance that would be covered by the referendum were supported by the community.

Open Forum

Ashley Schabilion spoke during open forum asking that the board not approve discipline policy 506, which was on the agenda for that night's meeting. The policy included the language stating the school may take disciplinary action against students who commit, "An act occurring off school grounds that disrupts, interferes, or otherwise affects the environment, activities, operation, students or employees of the school is prohibited."

"It's not unreasonable

Schabilion's concern was that the vague language of the policy was problem-

to foresee a situation in which an employee of the district feels off-campus acts of dissenting opinion are prohibited," she claimed. She went on to present a well-prepared argument, quoting court cases and logical conclusions.

Kasey Devine spoke next, regarding Supt. Tim Truebenbach's statements about Critical Race Theory (CRT) at the previous meeting. Truebenbach stated that CRT is not taught in Big Lake Schools as is not developmentally appropriate. Devine noted that many groups believe it is appropriate, and the issue continues to be pushed. Devine claimed the cultural competency training group Love and Struggle was in fact teaching these values, and there was a group of teachers trying to introduce this curriculum to the

schools. "Cultural competency training is mandatory, Devine stated, "but the existence of a dedicated committee promoting identitarianism, racial division, and whiteness doctrine is not mandatory."

Devine further asked the board to adopt a policy blocking these sorts of curriculum from entering the schools.

Teanna King was the final speaker, also speaking about CRT. She stated that the program needlessly divided children by race. She noted that the first amendment protects freedom of speech, but also protects against compelled speech.

"Training, exercises, or assignments that force students or employees to admit, accept, affirm, or support controversial concepts... constitute compelled speech," King stated.

She also spoke briefly about the dangers of requiring masks for students before she ran out of time. King promised to attend the August board meeting to fully voice her opinions to the board.

In Other Business, the Board:

- · Eliminated "walking zones" for the elementary schools due to earlier start times (students would end up walking in the dark for two months of the year, potentially creating unsafe
- conditions.); · Reminded citizens they were able to provide feedback on ESSER III funding by visiting the school's website;
- Reviewed campus main tenance items not covered by the referendum;
- · Reinstated a Youth Service Program, offering volunteering and educational opportunities to students, as a part of community education;
- Renewed MSHSL membership;
- Approved annually reviewed school policy.

and by January of 2020 the hearing in her right ear was diminishing. While seeing a chiropractor for her spine last summer, the osteopath suggested Daisy see a "medicine man" in Wisconsin who specialized in alternative medicine and spiritual healing. Feeling it couldn't hurt, Daisy made that appointment and it changed her world immediately.

to see doctors and specialists

After meeting with the medicine man, the doctor told Daisy that he was sure she had Lyme's Disease and put her on herbs and had her cut out sugar and gluten foods. Daisy used this information to see her family doctor

doctor went ahead and ran some tests, but the results for Lyme's Disease came back negative.

"However, they didn't

run the full tests," Daisy said. So, Daisy's Chiropractor, Katherine Miller, took Daisy to a Dr. Novak, a specialist she knew in the field of Lyme's and asked him to run extensive tests for Lyme's Disease. Two weeks later, Daisy was informed that that she in fact had Lyme's Disease. Finally, she knew what was causing all her distress.

"All this was so emotionally and physically exhausting for Daisy as well as the rest of us in the family," Brandon said. "They began we had hoped."

Where to Turn?

Daisy eventually heard from a friend about treatment for Lyme's Disease using Hyperthermia — a high-heat treatment that kills the strains of Lyme's Disease. Wholebody hyperthermia treatment puts a patient in a special thermal chamber. Then, using infrared-A-irradiation, the core temperature of the body is carefully increased. The goal is to bring the patient's body temperature to at least 106° F (41.1° C) , the point at which many strains of Borrelia (Lyme disease) are killed.

"I've heard of at least three other Lyme's patients around my age who have come back from Germany and are fine now," Daisy said. "So I contacted the doctors there and they got me an appointment right away."

GoFundMe

Daisy's sister, Adeline could see the misery her sister was in and the toll, physically, emotionally and financially the disease was manifesting. So she took action and created a GoFundMe page to help defray the costs of the Germany trip, and all the previous doctor and hospital visits. The GoFundMe page Adeline created had a financial goal of \$60,000 and by Wednesday of this week, 326 people had donated totaling \$31,522.



5 Ways To Catch More August Fish



started this "fake news" long ago - lol. In reality, the fishing this time of the year is at its peak — for all species of fish. And why not? As the water temps boil so do the metabolisms of the fish which means they burn more calories, which means they eat more, which means we catch more. See what I mean? The problem is what to write about, so I have decided to do an August sampler. A bunch of short blurbs of hot summer options that come to mind.

1. Walleyes in the Shallow Weeds.

Yup, I said shallow weeds — preferably cabbage weed, but any thick lush weed can work. I'm talking weed beds, weed flats, inside weed lines (the weed edge closest to shore, not the deep water weed line) or shallow outside weed edges — all in the five to 10 foot range. Of course if the water is brown vs clear it can be shallower vet. Work the edges or tops of these weed beds by casting or dragging jigging Rapalas at a fast pace. Hit the weeds once in a while and tear the bait free. Another option are swim baits and/or plastics worked the same way. Forget the deep walleyes, the hogs are always shallow. Anytime of the day is good.

2. Sunset Largemouth and Surface Baits.

Hit the edges of the slop, lily pads, docks or comb the tops of big weed flats. Slow moving surface baits like a good old fashioned Jitterbug or the plain jane cackling of a buzz bait are easy to use options. Whatever you choose, pick something slow and easy to grab if you're a fish in the dark, throw in some watery noise and hang on. Use a long rod with a forgiving tip in case your hooksets are premature. The sofeet tip will allow the fish a tad more time to inhale the bait and also has a built in delay you might need if you're trigger happy. I usually don't pay attention to the bait and only set the hook afeeter I feel the fish - not when I hear the fish.

3. Suspended Summer Crappies.

Most anglers give up on the big slabs when the spring bite is over. Mistake! Crappies can form huge schools during the summer. Find the suspended schools over deep water with your sonar during the day. They love to hang off

weedy points that cut out into the lakes basin, little "cuts or nubs" along lengthy straight massive deep weed lines or off the sides of underwater humps that have weeds growing on the tops. Typically they will roam around these objects suspended at the weed line depth. So if the weed line is at 12 feet, they may be suspended over 30 feet of water (usually 50 yards or less from the structure) at 12 feet.

That is also the depth they will be feeding at. The crappies will simply swim to the weed line as dusk approaches to feed. Once you figure out their "contact point" you're set. The fish

erally be there every night. Simp 1 y cast a 1 / 1 6 O Z tube jig, count it down to the "fishy depth" and slowly swim it back to the boat.

The fish will typically eat the bait within the first few feet of the retrieve. Pay attention to the surface near these areas as well-especially during an insect hatch.

4. Jumbo Perch

Deluxe.

Why wait for winter. Sleep in and head out around 9 a.m. There can be huge perch roaming deep weed lines or even the nearby mud flats. Make sure to also check mid lake rock piles – that's a secret by the way. Search and destroy is the key. Cover water fast to find these roaming scavengers. I like to use a one ounce bottom bouncer with a JB Lures hot flash series crawler harness. Use a small blade like a #2 Indiana and tip the harness with a night crawler chunk. A gold blade is a good choice. Move the boat around 1-1.5 mph. Depths can vary but the

tent window. The bonus are the walleyes and big bluegills you will catch as well.

5. Eelpout on Crankbaits.

Just kidding, that's an attention getter lol. Seriously, a good #5 option is the forgotten deep water northern pike. A good way to catch a summer monster is to fish them deep. Everyone can catch shallow warm water eater sized pike, but the bigger pike like cold water like a trout. Key on mid-range walleye spots in that 20-35 foot depth profile. Mid lake sunken humps topping off in that depth range, deep under water points intercepting deep water (50-80feet), and deep weed lines next to deep water all have potential to hold a big old water wolf. If these areas connect with the thermocline — perfect! Keep an eye on the sonar, because the big pike mark easily. The areas I described can also hold walleyes - which is important. Now get out the deep water muskies baits, giant

jig/plastic combos, deep diving monster crankbaits, or the biggest live bait you can find on a live bait harness and start fishing.

Oh yeh, you are going to need a bigger Well there ya go, a

short five topic burst of a few fun things to do when fishing on a hot August day. Next year I will do five

different options. Until then, enjoy the rest of the season. Lotsa Fish! Lotsa Fun!

Big Lake Twp. heard some good news at their recent meeting regarding Birch Lake. In 2009, the lake was declared an "impaired waterbody." lake had too much phosphorus in the water, which caused algae species to thrive. This resulted in an excess of algae and reduced water clarity. Many lakes facing this situation never

However, Birch Lake is a happy example of a successful restoration effort. In 2014, the Sherburne Soil and Water Conservation District completed a sub-watershed analysis to determine from where the phosphorus was coming. The state then awarded a Clean Water Funds Grant. SWCD and shoreline landowners collaborated to use the funding towards shoreline restoration and stormwater improvements. The township helped by installing stormwater infiltration basins on the west side of the lake.

The phosphorus level was lowered significantly by these efforts, and the state recommended removing Birch Lake from the "impaired waterbody" list this year. Hopefully, the county will be able to replicate this success with other

Messelt also noted issues with the way the state displayed precincts' reporting. The state website would show "all precincts reporting," which led voters and candidates to believe the votes were in, when it only meant that the precincts were reporting some of the ballots, not all. Home values are increasing around the county as homes consistently sell for 10% above asking price, on average. Messelt says this should not cause taxes to go up, however, so long as the tax levy remains the same for

the next year. The county hopes to have more county residents work within the community. On average, Sherburne citizens commute around an hour every day. This is one less hour for residents to shop within the county every day. Messelt says the county hopes to change this and stimulate the local economy.

The Northstar train is beginning to recover from the hit it took last year, though it is not expected to ever grow to the extent the state hoped. The jail is having a rough

time after the last year, as COVID-19 restrictions forced the Sheriff's office to limit the number of convicts admitted but had to keep the same number of staff (for sanitizing, etc.) American Rescue Plan Act (ARPA) funds are expected to help alleviate the situation somewhat.

The tax levy was raised last year in order to offer county employees a more

competitive wage. Employees were consistently being lost to metro counties that could pay more than Sherburne will ever be able to. Messelt said some of this is inevitable, due to the size of the county. He lamented the recent loss of a talented IT professional, who moved to the private sector and began to make more than twice what the county could reasonably pay. In Other Business,

the Board:

- ARPA funds and created a committee to looking into using the funds to expand town hall;
- Cancelled plans to fix the irrigation system as bids came back too high, and decided to leave the issue alone until plans were made for the potential town hall expansion;



Notice of Amendment to the Subsurface Sewage Treatment System Low Interest Loan Program Ordinance Ordinance No. 241

NOTICE IS HEREBY GIVEN that the Sherburne County Board of Commissioners amended the County's Subsurface Sewage Treatment System Low Interest Loan Program Ordinance to allow for water supply well replacement when necessary to meet setbacks for SSTS replacements or repairs, and setting both a maximum and minimum interest rate for loans. The above Ordinance was adopted by the Sherburne County Board of Commissioners on Tuesday August 3, 2021 and effective upon date of publication, and reads as follows:

SECTION 1.0 PURPOSE, AUTHORITY

1.1 PURPOSE AND AUTHORITY

An Ordinance establishing standards and procedures for providing low interest loans to single family residential properties, and owners of small business properties that have received a Notice of Non-Compliance for failing septic systems, and setting forth loan process, eligibility criteria, and repayment processes all in order to promote the health, welfare and safety of the public, and to protect the environment. This Ordinance is enacted pursuant to Minn. Stat. § 115.57.

SECTION 2.0 DEFINITIONS

The following words and phrases shall have the meanings ascribed to them in this Section. If not specifically defined in this Section, terms used in this Ordinance shall have the same meaning as provided in the standards adopted by reference. Words or phrases that are not defined here or in the standards adopted by reference shall have common usage meaning. For purposes of this Ordinance, the words "must" and "shall" are mandatory and the words "may" and "should" are permissive.

- 2.1 County: Sherburne County, Minnesota.
- 2.2 Department: The Sherburne County Planning and Zoning De-
- 2.3 Design Flow: The daily volume of wastewater for which an SSTS is designed to treat and discharge.
- 2.4 Individual Subsurface Sewage Treatment System or ISTS: means a subsurface sewage treatment system or part thereof, as set forth in Minnesota Statutes, sections 115.03 and 115.55, that employs sewage tanks or other treatment devices with final discharge into the soil below the natural soil elevation or elevated final grade that are designed to receive a sewage design flow of 5,000 gallons per day or less. ISTS also includes all holding tanks that are designed to receive a design flow of 10,000 gallons per day or less; sewage collection systems and associated tanks that discharge into ISTS treatment and dispersal components; and privies. ISTS does not include those components defined as plumbing under the Minnesota Plumbing Code, chapter 4714, except for a building sewer connected to a subsurface sewage treatment
- **2.5 Loan Application:** means an application form as prepared by the Department, for which an Applicant is required to complete and submit when seeking a Low Interest Loan in accordance with this Ordinance. 2.6 Midsized Subsurface Sewage Treatment System or MSTS: means a subsurface sewage treatment system, or part thereof, as set forth in Minnesota Statutes, sections 115.03 and 115.55, that employs sewage tanks or other treatment devices with final discharge into the soil below the natural soil elevation or elevated final grade and that is designed to receive sewage design flow of greater than 5,000 gallons per day to 10,000 gallons per day. MSTS also includes sewage collection systems and associated tanks that discharge into MSTS treatment or dispersal components. MSTS does not include those components defined as plumbing under the Minnesota Plumbing Code, chapter 4714, except for a building sewer connected to a subsurface sewage

2.7 MPCA: Minnesota Pollution Control Agency.

- 2.8 Notice of Noncompliance: A written document notifying a system owner that the owner's onsite/cluster treatment system has been observed to be noncompliant with the requirements of this Ordinance. 2.9 Program Administrator: The Sherburne County Solid Waste Administrator, or its designee.
- 2.10 Single Family Residence: means a single-family residential structure meeting the requirements of the Sherburne County Zoning
- 2.11 SSTS: For the purpose of this Ordinance, means a subsurface sewage treatment system for a Single-Family Residence having a design flow of no more than 2,500 gallons per day, and a subsurface sewage treatment system for an Eligible Small Business having a design flow of no more than 10,000 gallons per day. SSTS having a design flow of more than 2,500 gallons per day are not eligible for the Low Interest Loan Program unless it is for an Eligible Small Business

SECTION 3.0 LOAN PROCESS 3.1 ADMINISTRATION

eligible applicants.

The Sherburne County Solid Waste Administrator, or its designee, is the Administrator of this Ordinance and the Low Interest Loan Program. The Program Administrator will assume the responsibility for soliciting, collecting, and processing Low Interest Loan Applications, developing loan specifications, determining eligibility, and approving loan applications; and, monitor construction and approve disbursements of funds pursuant to this Ordinance and the Low Interest Loan Program.

for a loan pursuant to this Ordinance to finance site evaluation, design, installation, repair and replacement of individual sewage treatment systems. All persons having an ownership interest in the property must join in the Loan Application. If a property is being sold on a contract for deed, both the vendor and vendee must sign the application. Applicants must provide proof that they are current in payment of all property taxes and in payment of any mortgage. No income or asset limitation shall apply to

A. Eligible Applicants. Owners of eligible properties may apply

- B. Eligible Small Businesses. Businesses must meet all of the following criteria to be eligible for a loan pursuant to this Ordi-
 - (1) The business has a physical or industrial location (based on property tax classification) in Sherburne County.
 - (2) The business is registered with the Minnesota Secretary of State and not debarred by the State of Minnesota. (3) The business has no more than fifty (50) full-time and/

 - (4) The business generates less than \$1,000,000 in average annual revenue from all sources.
 - (5) The business has no current tax liens on record with the Minnesota Secretary of State and all required licenses and
- permits are in good standing. C. Eligible Properties. Loan Applications will only be accepted
- for improvements to Single Family Residential properties and El-

igible Small Business properties, as determined by the Program Administrator. In addition, eligible properties must meet all of the following criteria as determined by the Program Administrator:

- (1) With the exception of the noncompliance status of the SSTS serving the property, the Property be in compliance with all applicable local ordinances and permits, including, but not limited to, the applicable zoning ordinance and zoning permits, and the County's Solid Waste Management
- (2) The property must be improved with a permanent Single Family Residence or a commercial or industrial structure for an Eligible Small Business. Mobile homes are eligible only if they are located on a permanent foundation, have the wheels and axles removed, and are taxed as real property.
- (3) The property must be located outside of an area that has a municipal sewer system and where extension of a municipal sewer system to serve the property is not imminent, as determined by the Program Administrator.
- (4) The property must be located entirely within Sherburne (5) The property is not delinquent on their property taxes
- and/or mortgage(s). D. Eligible Improvements. Loan proceeds may only be used for the following improvements and expenses related to the replacement or repair of a failing or non-compliant SSTS (as determined
- pursuant to MPCA rules by a licensed septic inspector): (1) SSTS design and construction costs.

- (2) Plumbing and electrical costs directly related to and necessary for the SSTS. (3) Replacement of tank(s) and/or drainfield repairs that
- will bring existing system into compliance with applicable MPCA rules (e.g. Minn. R. ch. 7080 to 7083). (4) Seeding the SSTS installation area, only to extent re
- (5) Placement of holding tank(s) may be an eligible cost only if no other SSTS can be installed at the property.
- (6) Installation costs for a new water supply well on the applicant(s) property only if a new water supply well is necessary in order to meet setbacks to the SSTS as required in MN Rule 4725. All water supply well work shall be performed by a licensed well contractor in accordance with
- (7) If available as an alternative to replacement or repair of a failing or non-compliance SSTS, as determined by the Program Administrator, sewer access charges for connection to a municipal sewer system.
- E. Ineligible Improvements. Loan proceeds may not be used for any expense that is not specifically identified as an eligible improvement or expense in this Ordinance. Loan proceeds may not be used for an SSTS to facilitate new building construction or a new dwelling unit. Loan proceeds may not be used to increase the capacity of an SSTS beyond what is reasonably required to serve the existing Single Family Residence, or Eligible Small Business. With the exception of design costs, no improvements commenced or expenses incurred prior to the Department approving an application and issuing a Notice to Proceed will be considered to be an eligible expense. Notwithstanding the foregoing, the Program Administrator may allow proceeds to be used for improvements commenced prior to application if the Program Administrator de-
 - (1) The improvements are otherwise eligible improvements
 - (2) The improvements were commenced as part of the same SSTS project for which a loan is being issued; and
 - (3) The applicant has shown good cause for why the improvements were commenced prior to the application ap-

The Program Administrator's decision as to whether or not to allow loan proceeds to be used for improvements commenced prior to application approval shall be final.

LOAN APPLICATION PROCESS

- A. Loan Application. Owner(s) of eligible properties must complete a Loan Application form as prepared by the Department, and submit that form to the Department for review. Incomplete applications, as determined by the Department, will not be accepted. Loan Applications shall require the following information, at a minimum:
- (1) Proof of ownership for all of the affected property; (2) A copy of the last or most current mortgage statement or satisfac-
- (3) A copy of the Notice of Non-Compliance from a Minnesota Licensed SSTS Inspector for the septic system on the property;
- (4) A non-refundable loan application fee as established in the Coun-
- (5) For applications relating to an Eligible Small Business properties, a copy of the business's signed federal tax returns for the two years prior to the application and, if requested by the Program Administrator, a copy of the business's income statement/profit-loss for the two years
- prior to the application. B. Application Review. The Program Administrator will review the Loan Application and determine eligibility. Loan Applications will be accepted throughout the entire length of the program or until funds are expended. The Program is discretionary by the County and is subject to the availability of funds. Applicants who do not qualify will be informed by the Department in writing as to why the Application was rejected. The Program Administrator's determination of eligibility pursuant to this Ordinance shall be final.
- C. Funding Priority. Because the Loan Program is subject to the availability of funds, the Department may prioritize loans for properties where the SSTS has been determined to be an Imminent Threat to Public Health or as Failing to Protect Groundwater, as those terms are used in MPCA Rules. In order to ensure that funding is available for priority projects, the Department may defer its decision on a Loan Application for any property that has transferred ownership within the preceding 12 months until the Department is reasonably able to determine whether funding will be available for priority projects during the budget year. No loan may be approved for any property that has transferred ownership after the effective date of this Ordinance, if a Certificate of Compliance is not provided to the Department at the time a Certificate of Real Estate Value is filed, as required by the County's ordinances and applicable regulations.
- D. Loan Documentation. If an application is approved, the Applicant(s) must submit the following documentation to the Department:
- (1) A completed SSTS Permit Application, along with the required permit fee, or, if the property is located in a City or Township that issues

its own SSTS permits, a copy of the approved SSTS permit issued by

- (2) A copy of the SSTS design for the SSTS permit application or for the approved SSTS permit, as prepared by a Minnesota Licensed
- (3) Lien Recording Fee and Satisfaction of Lien Fee.
- (4) At least two (2) proposals from licensed SSTS installers itemizing the total costs of the proposed project. Applicants are not required to select the lowest proposal, but the information may be used by the Department in determining the total amount of the loan to be issued. Project costs that exceed the total amount of the approved loan shall be the sole responsibility of the Applicant(s). The County shall not be responsible for any amounts that exceed the total amount of the loan, as determined by the Program Administrator.
- E. Special Assessment Agreement. A loan issued by the County pursuant to this Ordinance shall be a lien on the property and will be collected as a special assessment with the property's real estate taxes. After approving a Loan Application, the Department will prepare a Loan and Special Assessment Agreement. All owners of the property shall sign the Loan and Special Assessment Agreement before any loan proceeds are disbursed. The Loan and Special Assessment Agreement will not be recorded until disbursement of the loan proceeds.
- F. Loan Terms. A loan approved pursuant to this Ordinance shall be issued on the following terms:

Single-Family Residence: \$20,000. Maximum Funding: Eligible Small Business: 75 percent of SSTS

loans up to \$25,000; 80 percent of SSTS loans up to \$50,000; 85 percent of SSTS loans up to \$75,000; 90 percent of SSTS loans up to \$100,000; and, 100 percent of SSTS loans exceeding \$100,000 up to maximum of \$150,000. Shall be determined annually on February 15th based on the cumulative average percentage

increase as set forth in the Consumer Price Index Midwest for all items (CPI-U Midwest), as published in the Bureau of Labor Statistics for the immediate current year, but shall not be less than 1.2 percent, nor greater than 3

Non-refundable fee per application. Application Fee: Lien Recording Fee: \$46.00.

Lien Satisfaction Fee: \$46.00.

Repayment:

Interest Rate:

Payable twice a year as a Special Assessment included with the Property's real estate taxes. Property owners may prepay the loan at any time. The loan shall become immediately due and payable in full upon any sale, conveyance or other transfer of the Property. **Single-Family Residential properties:**

Payable twice a year over 5 years for loans up

to \$5,000. Loans greater than \$5,000 shall be

Term of Repayment:

payable twice a year over 10 years. Eligible Small Business properties: Payable twice a year over 5 years for total funding up to \$25,000; Payable twice a year over 7 years for total funding up to \$50,000; Payable twice a year over 10 years for total funding up to \$75,000; Payable twice a year over 12 years for total funding up to \$100,000; and, Payable twice a year over 15 years for total funding

over \$100,000, up to \$150,000. None for Single Family Residential properties.

- G. Penalty for Ordinance Violation. If, during the term of any loan, a court determines that a violation of any Ordinance or land use permit or license exists on the property encumbered by a Loan and Special Assessment Agreement, the loan shall become immediately due and payable and the collection schedule for any assessment for the remaining outstanding balance shall be accelerated and shall become payable in full with the following year's
- H. Notice to Proceed. After all documentation and fees required by the Ordinance have been received, the Department will issue a Notice to Proceed to the Applicant's selected contractor. The Notice to Proceed will identify the total amount of the loan that has been approved.

SECTION 4.0 LOAN PAYMENT 4.1 VERIFICATION OF PROPER INSTALL

All SSTS improvements must be made in compliance with Minnesota Statutes, the rules and regulations of the Minnesota Pollution Control Agency and County and other local Ordinances. Prior to disbursing any loan funds, the Applicant or the Applicant's contractor shall provide the Department with an invoice and copy of their SSTS as-built verifying that the SSTS was properly installed and approved by the applicable permitting authority.

4.2 LOAN DISBURSEMENT

Upon verification of completion and approval by the Department of the total project costs, the Department will disburse the approved loan funds jointly to the Applicant and the Applicant's contractor. The Applicant's contractor shall provide the Department with a lien waiver for the property. The lien waiver and the Loan and Special Assessment Agreement shall immediately be recorded with the County Recorder. SECTION 5.0 GENERAL PROVISIONS

This Ordinance shall not relieve or lessen the responsibility or liability

of any person owning, operating, controlling, or installing any sewage treatment system or disposing of septage for damage to persons or property or any other injury occasioned thereby. The Administrator assumes no responsibility for the proper, safe, and efficient functioning and performance of sewage treatment systems installed, renovated, or maintained pursuant to the requirements contained herein.

It is not intended by this Ordinance to appeal, abrogate, annul, impair, or interfere with any existing easements, covenants, deeds, restrictions, agreements, Ordinances, rules, regulations, permits previously adopted, or issues pursuant to law. However, where this Ordinance imposes greater restrictions, the provisions of this Ordinance shall govern. **5.3 EFFECTIVE DATE**

This Ordinance shall be effective after formal adoption by the County Board and publication according to law. (Published in the *Patriot*: 08/07/21).

"ASK A TROOPER" by Sgt. Jesse Grabow of the Minnesota State Patrol

Question: What is the purpose of solid white lines, separating traffic moving in the same direction? Example the ones leading up to the Lowry tunnel in Minne-

apolis. Does it make it illegal to change lanes?

Answer: Pavement markings direct and regulate traffic. While there are several different types, we will focus on white lines.

White lines separate lanes of traffic traveling in the same direction. A line composed of white dashes indicates that drivers can change lanes in areas where this type of marking is present.

A line of shorter and thicker white dashes indicates that the lane will end.

A solid white line indicates that lane changes are discouraged in areas where this type of marking is present. Solid white lines also mark crosswalks, stop lines at intersections, parking stalls, and the edges of a roadway.

Double solid white lines indicate that lane changes are prohibited in areas where this type of marking is present

A solid white line with a bicycle insignia along the side of the road indicates an area is designated for bicycle traffic only. Bicycles must travel in the same direction as adjacent traffic.


